All LEA educational partners were involved in developing the plan. Parents participated in School Site Council (SSC) and LCAP Advisory Committee meetings on a monthly basis. Community members participated in monthly District Governing Board meetings. Teachers gave feedback at weekly Teacher meetings, and at School Site Council meetings. All school staff met monthly to discuss and address the needs of our entire school. Feedback was also solicited from students, parents, and staff during our LCAP discussions regarding needs and wants in formulating our future goals, services, and activities. In addition, our School Site Council sent home a survey to all families to assess our strengths and weaknesses and set future goals and services to address our needs.

Additionally, during the beginning of the 2021-2022 school year, teachers met with 100% of parents to personally discuss and receive input on how our district should prioritize COVID-19 recovery efforts, specifically in the areas of safe in-person learning, lost instructional time, and other pandemic impacts. This feedback will not only help to maximize teaching and learning for all students, it will ensure the meaningful engagement of all families in their children's education. All families, including those with students who speak a language other than English, students who participate in Trinity TANF, and students with exceptional needs had an opportunity to meet with their children's teachers to discuss concerns, needs, and goals. This feedback was shared with school administration and other support staff.

Junction City Elementary evaluated its stakeholder engagement opportunities and determined that civil rights groups, disability rights organizations, and other formal advocate groups are neither present nor served by the LEA.

Feedback from the community engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the ELO and LCAP remained consistent with current feedback, including a commitment to in-person learning, smaller class sizes and personalized instruction, small group support for math and reading, along with maintenance of a strong counseling support program, student interventions, enrichment opportunities and high quality after school opportunities. The services and opportunities for students as described in the ESSER III plan incorporate this feedback and continues to build on the ELO and LCAP goals of supporting safe and continuous inperson learning and addressing the academic, social, emotional, and mental health needs of all students.
